

# Lennox Manufacturer Certification Statement Under American Recovery and Reinvestment Tax Act of 2009

## FEDERAL TAX CREDITS FOR QUALIFIED ENERGY-EFFICIENT HVAC IMPROVEMENTS—RESIDENTIAL NATURAL GAS/PROPANE FURNACE, OIL FURNACE, GAS/PROPANE/OIL HOT WATER BOILER, AND ADVANCED MAIN AIR CIRCULATING FAN PRODUCT CATEGORIES

Taxpayers claiming a credit for Qualified Energy Property should retain this Certification Statement for taxpayer records.

Under the American Recovery and Reinvestment Act of 2009 (ARRA), the U.S. Internal Revenue Service (IRS) is implementing consumer tax credits for homeowners who make qualified improvements of higher-efficiency HVAC equipment to their primary residences. Tax credits are effective for all qualified energy property systems installed from January 1, 2009 through December 31, 2010.

### CERTIFICATION STATEMENT

Pursuant to this Certification Statement, Lennox Industries Inc. certifies that each of the following products constitutes Qualified Energy Property and meets required standards to be considered eligible for an energy-efficient property tax credit as set forth by Section 25C of the Internal Revenue Code.

Lennox® natural gas/propane furnaces that meet an AFUE of 95% or higher, gas/propane/oil hot water boilers that meet an AFUE of 90% or higher, and gas and oil furnaces that incorporate an advanced main air circulating fan that uses no more than 2% of the furnace's total energy, and also meet Federal standards for Qualified Energy Property:

#### 95% AFUE FURNACE

Qualifying furnaces are eligible for a tax credit of 30% of the installed cost, up to \$1500.

#### 90% AFUE BOILER

Qualifying boilers are eligible for a tax credit of 30% of the installed cost, up to \$1500.



#### FURNACE MODELS INCORPORATING A QUALIFIED MAIN AIR CIRCULATING FAN

Furnaces incorporating a qualifying advanced main air circulating fan are eligible for a tax credit of up to 9% of the installed cost of the furnace, up to \$1500.
